

The Alliance Handbook

Introduction:

As a member of the Alliance PMA, you have joined an organization that is structured to engage leadership within the private sector, and to empower the private sector to create meaningful change that makes sense for the good of all. You are joining a host of people who want a better fairer world, a world that refutes and halts dictatorship, and unnatural violence against people and Nature. We are the many, and we hold the power of peaceful transformation through our economic unity. No matter how divided the country appears, divided by ‘uniparty’ politicians of sowing chaos to steal control while we the people are distracted, We, the people of every type and persuasion, all see the need for a regenerated food supply, and nontoxic products, practices and life upgrades. The left and right paradigm dissolves into harmony at the table, where we meet to eat real food, it dissolves when we build homes that are healthy, it dissolves when we want fair compensation, and honorable honest leadership that is wholly accountable and directable. The Alliance is the realm of unity for repair, diligence and prosperity.

The Alliance’s structure will be explained throughout these pages. Each of you, reading it, own it for the good of all, and generations to come. It is a way to peacefully form the power of the people into a mighty economic contender for global fairness and healing. While we are seeing a rapid change in the public sphere, with radical erosion of our right to privacy and our base liberties, the Alliance PMA is a realm where we reinforce them and put down rebellion against our right to be free and peaceful. The Corporate Political Violence directed at the People is broad and multidimensional, the Alliance is a virtual space of sanctuary. In these pages you will read how we build this sanctuary, how we maintain it, and how it will carry on for future generations when we are gone.

1) The PMA Contract and Pledge

Entrance into the Alliance begins with a Pledge and a Contractual Agreement amongst members. You will find The Pledge and Agreement in appendix 1. Our peaceful virtual realm is valuable and we need the means to keep it clean of saboteurs, and violators. First, what is a PMA? A PMA is a private membership association, it contains mutually beneficial terms, and it excludes some in society, and includes a specifically defined set of people. We use a PMA to create terms of contracting, which can be thought of as terms of behaving that support our way of life, and our endeavors. By joining we have entered into a lawful contract, and within that contract, as long as we are endeavoring to improve each other's lives in a peaceful manner without trespass on those outside the PMA, we have the room to create a realm that operates with improved outcomes for members. Everything, and anything we agree to is available to us, in the PMA, and the only lawful limit to our behavior is that is not "evil".

Since much of what our Alliance will be establishing is a restoration of perpetual rights defined in American Founding Documents and creating lawful space for these rights to be properly understood, offered, protected, and served, absent corruption and for Alliance members in America and abroad, we have a good set of tools to initiate our transformation. The Alliance uses these tools, but is not limited by them, since tranquility is not the descriptor of America post arrival of the colonialists. Nor is the Alliance going to neglect our preservation and protection. Our welcome mat leads to a virtual fortress complete with protectors and builders. We want a lawful organization for families of the next generations to use, that has the best tools of law and practice well in hand and well understood.

The Pledge and Contract to become a member leads away from broken systems into working models for our engagement as responsible people, responsible for our own integrity and responsible for the quality of Alliance integrity. The Alliance is attractive to people who know that systems in our public realm use complexity to hide corruption, and you will find that our model for justice, for money, for inclusive engagement is not complex. Its simplicity is in fact its strength, and importantly its responsiveness to the best ideas of its members is its fuel. Everyone of basic intellectual capacity will be able to participate in the implementation of the Alliance structure, and improve it, tweak it, and strengthen it. It is hoped that the simplicity offered here will be revered for it serves as a window into the spirit of humanity, and the higher passions for love, creative joy, and service.

In these coming pages you will see how the Alliance PMA will conduct its need for internal justice, how it will conduct its need for trade with a stable means of exchange (money), how it will make changes collectively, how it will manage its collected wealth, how it will provide room for individuals to experience Innocence, how to support greater individual and collective purpose and creativity and how to attend to those who become dishonorable.

As a member you are bound to the terms of your Pledge and the Contract. You may leave at any time, and you could be removed if your behavior warrants it, further your behavior may warrant lawful punitive processes, the Alliance is stronger for ‘nipping dishonor in the bud’. Members do not spy on one another; however, we do hold one another to account. You will find that the Natural Justice model allows for plenty of pruning of behavior incompatible with the Alliance without much fanfare or public discord. Envision these terms as a great home, a home that you have as your own, to protect you and keep you warm, a place where you can expand into your most gracious experience of yourself in the life you have organized for yourself, with its exquisitely unique qualities and skills.

Many of the overarching ideas may be familiar, and some may appear too promising, so much of our experience as the private sector has been to expect less, and live with it. The Alliance is a space to create a quality of mutual engagement to be happy about, to relish and to cherish. It allows each enough space to be unique with the strength of others supporting your uniqueness because their uniqueness is supported as well. The Alliance refutes indenture and enhances personal empowerment. As you learn more about the Alliance in these pages it is a good time to introduce the concept of Prosperism, and a model of currency that is based on a 4 dimensional collateral. That collateral is our health, wellbeing, our peace, strength and excitement for the future, our relationship with Nature, and our experience of mutual care and respect. The Alliance will collateralize the economic environment it co-create, and both members and outsider will see its success, and its common sense. More on our stewardship in pages to come, and our Alliance currency.

The reason we do not allow Government as members is simply because our governments, even while hosting many servants of excellent intent, has followed a destructive path, and shows that it is irretrievably complex and secretive. Harsh outcomes we deal with are a result, outcomes that

urgently need the Alliance's attention with as much unified power as can be mustered and applied.

The Mother Trust UNA

The Alliance is structured to manage the disbursement of (public) money that arrives through membership subscriptions. It comes in through the members' payment of a subscription, a set amount to accomplish the Alliance services is retained for administration, that amount is 25% of the revenue. The remainder is sent to a trust account called the Mother Trust/UNA managed by 5 trustees.

Trustees Pay

At no time may any trustee be paid greater than 250k yearly (in US dollars), in equal portions, maximum yearly 250k or 62.5k per quarter. Trustees may use any portion of their pay they wish to hire additional services. Should the amount generated for the trustees allow, they may choose to hire additional representatives to aid in delivering their service. Any greater amount (than 1.25 million yearly) that may be generated within this portion may be used for additional hires to serve administration of the trust if needed or used to increase the 5 sections of the Mother Trust/Una's pool.

Trustees will be initially appointed by the Founders, afterwards replaceable through the PEG process adapted for leadership selection, and thereby electable. The roles of these trustees shall be detailed in this chapter.

The amount in the Mother Trust is dedicated thus:

1% of funds is to pay the 5 trustees in equal portions.

25% of remaining funds are dedicated to the following four foundational purposes, 6.9% to each:

Land:

The purchase of land to be held by the Alliance in the Alliance's Land Trust/UNA, for regenerative farming, sustainable communities, and village housing. Members are Beneficiaries of this land and are invited to demonstrate best stewardship, practical skill growth, natural creative industriousness and excellent mutual respect and collaboration to earn life-long lawful status on these lands for themselves and heirs that follow. Generations to come, guided and trained by current wisdom, will have land security within a growing network of Alliance members, with best stewardship (rather than most extraction) as the terms of right to occupy.

Given the abundance of elders as baby boomers, these lands will also serve as life finishing homes in community, integrating land security for next generations, with aged tending to those purposes that can be accomplished as age progresses. Communities will be oriented to grow regenerative and organic produce and humane livestock, produce quality foods, for their own needs and for trade. Rather than sequester elders away, The Alliance will focus on creating an environment where elder purpose is continued in a variety of roles.

The actual lands purchased, and the projects that arise from the Lands portion of disbursement are the object of the entire Alliance's attentive proposals, using proposal enactment governance (PEG), and the character of the lands and projects will reflect the best determined proposals, as selected by the membership. Any member may make a proposal, and the members themselves vet and place priority on the ones most solid and advantageous to the Alliance. One of the Mother Trusts' trustees is dedicated to the funds disbursed to Land and may make proposals to the membership that stand out by color, Green, for the members' consideration.

While 6.9% of the Mother Trusts' UNA funds are dedicated to the purchase of land for the Alliance, the Communities of the Alliance are not limited in their own capacity to spend on land or other projects, nor will they have to put their proposed land purchases into Alliance Land trust(s). However, if the wisdom appeals to the proposer, and the proposal is selected, that avenue will be made available.

Well-Being

6.9% of the total amount in the Mother Trust will be dedicated for disbursement to proposals that consider the health and wellbeing of the Alliance members. The members may propose to create

a dedicated emergency account in lieu of traditional health insurance, however this is just an example, it is wholly up to the membership to propose, select and fill that which they know is needed.

Because the Alliance IS a PMA, healing modalities are available that would otherwise be prohibited by a slew of regulatory inhibitions. The healers are practicing in an environment where profiteering is not supported, and the actual value of their skill is accurately reflected by the Alliance through testimonials and member 1-5 star color-coded ratings. Members are not permitted to ‘sue’ healers for money, they are however, allowed to make an accusation and call out questionable acts or practices through the Natural Justice process, shared later in this book, and have member- mediators decide the remedy. Therefore, no healer needs to carry malpractice insurance, although they will be subject to action.

Well-Being is of course a result of many dimensional alignments, so the breadth of proposals for this sector of funding may be broad. It will be up to the Alliance membership to define its needs within proposals and fund them. It may be useful here to reiterate that the Alliance itself may offer remedy from within its membership, however, it exists to encourage and stand for the right of the individual to conduct their life choices regarding health with expertise they value and support that freedom. Membership may voluntarily choose to adopt a practice that serves improved health outcomes and may use Natural Justice to accuse any member of harming or endangering another’s health, however, the Alliance shall always stand for individual rights and liberties and bodily autonomy of adults and their decisions for their minor offspring.

The Trustee selected to oversee the disbursement of 6.9% of the Mother Trust’s WellBeing funds is an individual who is well versed in healing modalities and able to communicate broadly with recipients of disbursements. More on the role and responsibility of the trustee later.

Education

Like the other 3 foundational purposes, the Education portion is 6.9%. Here the Alliance begins to fund the transformation of educative formats and the terms of education itself. Growing on

existing efforts to bring new training to people of all ages and training that is desired, not compelled, is at the core of Education cornerstone in the Alliance. A versed Trustee will represent this cornerstone and oversee the disbursement of funds into new educative efforts.

Overlap between Well Being, Land, Law and Education is to be expected, thus a parcel of land could be purchased and next populated with people in training to create a regenerative community, in this case the Education Trustee might flag support for a proposal to use the Education fund for this purpose, and Alliance members can have the benefit of that leadership, which will be noticeable by the color coding of the proposal in the proposal lists.

Alliance members capable of providing training in trades and skills will be needed to help get new communities off the ground. The trustees for the cornerstones will coordinate so that proposals are filled from the appropriate pool.

An education Focus group is engaged now, in the pre-launch of the Alliance subscription to bring forward new educational structures and reform of compliance-based education to purpose driven passion support. One of the Communities in formation of the Alliance is the Ravencroft Community, dedicated to education. It is currently open to focus group participation, and will be offering a Community within the Alliance that focuses funds to empower the transformation of training for all ages.

Law

The call for the Alliance is arising because the people across the globe are experiencing a ‘Great Awakening’, and are recognizing that to acquiesce to obvious existing corruption in action is leading to a future we do not want for our children or our Earth. Our right to repair is perhaps instructed most potently in the US Constitution, and yet, with legal acumen, our job is to create a lawful, protectable, predictable, reliable path to repair of our economic methods such that environmental repair is rewarded, encouraged and supported, and the people are not subjects or indentured to corporate contracts that undermine the future of our planet and our children.

This cornerstone exists to fund the awareness of rights, the protection of our activity, and the service of representation to other members who focus their efforts in the many realms that need

attention. The farmer, the healer, the producer of product and service may operate in a hybrid fashion available to the public or available within the Alliance only, with support to fend off lawfare expected from corporate powers invested in control and manipulation of populations' individual liberties, often under the guise of safety and convenience.

The 6.9% of the MotherTrust will therefore be dedicated to the costs of lawful protection, benefiting all members of the Alliance. The Alliance and EdensBay Marketspaces have been exhaustively researched for their basis in law, and are offered as defensible, lawful avenues for the people of the private sector to retrain themselves for honorable prosperity and promote wellbeing in our wake. Where the Alliance arises in other countries, the focus group engaged in the Law cornerstone will be describing the shield for reparative activities of the Alliance working with the set of laws of the variety of countries that become represented in the Alliance.

Focus Groups

A focus group, as with the other three foundational cornerstones is under organization, to generate Trustee leadership and awareness of the rights we actually have, but must be aware of to implement fully. Rights that more people will need to well-employ to be able to stabilize the future for the good of humanity. The Focus group will be inviting existing experts to become powered by the Alliance and make their gifts of knowledge and empowerment more widely available.

Since many a person is aware of the outcomes of corruption, thus the motivation to organize with empowerment by the Alliance, but fewer are aware of the actual activities that create corruption, and the practical application of law and contract to unravel it, the Alliance provides a realm where a new beginning evolves, separate from the ruinous practices of the elite driven old one.

This handbook will be updated as progression of the Alliance occurs. Focus groups are engines of change, think of them as thinktanks complete with action outcomes. The new Alliance member is invited to make known their interest in any of these foundational focus groups, or to establish one they see needs to come to fruition. Focus groups are unpaid and arise to cause a posited change then dissolved or absorbed into that change manifested as action.

The Volume of the Mother Trust

AS described above 1% of the Alliance Mother Trust pays the trustees, and 25% of the remainder is partitioned in four equal portions to the Law, Wellbeing, Education and Land cornerstone purposes. The amount or volume in the Mother Trust is entirely dependent on the number of members and the amount of their subscription. The founders have been working with conservative numbers, not expecting greater buy in than minimal. During the pre- Beta (proof of concept working model) EdensBay Marketplaces, the founders are also vetting the appetite for set minimum subscriptions, vs self-selected subscription amounts, albeit with some minimum. Either should be attractive and affordable and scalable as the new members find the benefits out for themselves of using the Allied Coin that is issued for every subscription amount.

For the sake of describing the **Powered By the Alliance** slogan, we shall look at the outcomes of 100k members each subscribing for 35 a month. This appears as a reasonable benchmark to deliver, since 100k members additionally will have amongst them vendors and classified ad type sales wherein the 35 allied coins can be spent for tax-free purchases, to the advantage of the membership. The volume within the Mother Trust will be, in a round number (payment gate costs estimated) 7.5 million per quarter. This means that 100k members will have money to fund proposals they make in any one of the four cornerstone areas and money left over for general proposals, while keeping the purchase value of their money by using allied coin together.

One can readily see that an Alliance that is able to use more than 35 Allied coin a month to purchase tax free goods and services from one another as a matter of private exchange, will increase that pool voluntarily. Thus, if the average use of allied coin becomes 100 a month (the member volunteers 100 a month for 100 coin), the Mother Trusts' volume nearly triples. As the structure of the Alliance; Trustees elected by the members, with accountability through Natural Law (explained in this handbook) to the members becomes strengthened by use, along with PEG, proposal enactment governance- more on this shortly, membership and vendors increase, and confidence in transitioning to the internal Allied Coin shall also increase, and the volume of the Mother Trust increases, creating for the Alliance and empowerment that is meaningful and changemaking for the good.

Open Alliance Members

The Fifth Trustee oversees the distribution of the funds that are not cornerstone applied as follows:

The individual member may choose to belong to an Alliance Community, or may be an Open Alliance member. If the individual does not choose a Community to belong to within the Alliance, the value of their personal subscription revenue shall remain in the 5th segment of the mother trust, and this member will have the capacity to create proposals and vote on proposals that are funded from this portion.

Alliance Community Members

A member that joins an Alliance Community **Powered by the Alliance**, will contribute to the 25% dedicated to the four Alliance cornerstones as will the Open Alliance member, and then have the remainder of their subscription move to a sub trust belonging to their Alliance Community. This creates a stream of financial empowerment to the goals of a specific community, allowing for growth according to specific passions of Alliance members.

Allowance of membership in multiple Communities is possible with greater subscription amounts, a minimum subscription per community. This allow for the community to benefit from the members involved, and the resulting Allied coin for the extra subscription is usable throughout the Alliance networks. For example, a member wishes to be involved in 2 Alliance communities, they agree to subscribe minimally at double, and receives double the minimal allied coin (70, according to parameters already given above), while their individual contribution to the Mother Trust is therefore: 25% to the 4 Foundational Cornerstones, and 50% of the remainder to each of the Communities. One can readily see that a member can join any amount of communities by simply increasing their minimum subscription, and splitting the remainder into 3rds or 4ths (+) and sending it to those communities' sub trusts. It is not expected that many members will feel the need to join numbers of communities, however, if they do, the capacity is there. Also, of course the member may wish to be in the Open Alliance and additionally a

member of an Alliance Community(ies) and therefore be in position to propose and receive funding from both, or all of those portions. Any Member may propose and receive funding in fulfillment of the 4 Foundational Cornerstones.

A Community of the Alliance may be formed that already has membership costs associated by the CEO of that community, remembering that in the Alliance, CEO stands for Community Executive Organizer. Let's walk this through. A larger pre-existing organization may wish to be financially empowered by the Alliance, they may wish to use the PEG method for self-governing, -see next section, and they might like to be interconnected with more potential members and with like-minded people. Being a Community in the Alliance can relieve much of the fund-raising ordeal of many a civic minded organization.

If the Community has an additional charge beyond the Alliance's minimum subscription to belong, that Community will be listed with an orange color coded message; "*Additional charge to join this community.*" These communities will prepare their own payment terms and gates. The CEO's of these communities are responsible for vetting the members of their communities and collecting payment in the currency of their choice. All communities agree to use Natural Justice to resolve issues, and all members as well, and any community may be expelled from the Alliance should irresolvable issues arise, and their Sub Trust dissolved. In which case the innocent members of that community will be invited to remain in the Alliance and the money that was in their (Named) Alliance Community Trust is restored to the Mother Trust.

Great care will be taken to ensure that Communities that join are in alignment and that such an event is prevented. Additionally Natural Justice shall be employed to develop a just outcome. However, if there is an accusation of sabotage or fraud of any substance, the Community may be immediately suspended by the Founders, or The Mother Trust trustees, or by Natural Justice's second mediative circle, until such time as the accusation is fully vetted, and its members notified of the fact. In such a case the Community's status will be made known within the Alliance.

An organization that chooses to be empowered by the Alliance is entered into the Alliance either as an organization of a community built from scratch by a team of members, or as described, a

preexisting organization that uses the Alliance governance and funding structure to further empower it. In the former case, guidance and support will be offered to new CEOs and these will select a mission and name and become listed as a **Forming Community**. A Forming Community will remain a forming one until the community reaches 2500 members. When the community has achieved 2500 members, the community is granted its own Mother Sub Trust, which it names, after the name of their community.

Trustees of an Alliance Community's Mother Sub Trust

The trustees of a community with 2500 members are selected by the Community, through the PEG proposal enactment governance, and these trustees are paid 1% of their Communities Sub Trust, divided between them and paid at the onset of each quarter based on the previous quarters funding. There are 3 trustees, and the trusts' structure and formation is created in solidarity with all the other trusts, with equal language, describing the members' selected proposals with beneficiary status. These Trustees shall be confirmed by the Mother Trustees, and instructed, the Mother Trustees reserve the right to object to a trustee, based on an accusation that is in turn vetted through Natural Justice, in such a case the members use PEG to select another. The Trustees are bound by duty to both the Alliance and their community. They can be removed and changed by election.

Upon reaching 2500 members, the community will receive its own page with its own PEG process for spending its funds, and PEG election process for electing their trustees. The cumulative amount of members' subscriptions according to the formula above is dropped into the (Named) Alliance Community Trust at the end of the quarter. This formula once more is $(\text{members' subscription}) - 25\% \text{ for admin of the Alliance} = 75\% \text{ to the Mother Trust, } 1\% \text{ for Trustees, then } 6.9\% \text{ dedicated to each } 4 \text{ Foundational Cornerstones, and the remainder to the (Named) Alliance Community Trust for use by the community of } 2500+ \text{ members. Remember the minimum is what is calculated, however, members may increase their subscription amount according to their current desire for additional Allied Coin, resulting in an increase to the Mother Trust, and thereby, and increase to the funds in the (Named) Alliance Community Trust.}$

Using round numbers, let's say the Alliance has in total 500 k members all contributing 35 a month by subscription (remembering the payment gate costs roughly 2.5% of each monthly subscription which must be calculated), thus we round the subscription to 100 a quarter per member. $500k \times 100 = 50\text{mil} - 25\% = 37.5 \text{ million} - 1\% \text{ (Mother Trustees Pay)} = 37.125\text{million} - 25\% \text{ (6.9 \% dedicated to Law, Land, Wellbeing, and Education)} = 27.84 \text{ million on the Open funds.}$ If the Community in this example has 2.5k members at 100 each per quarter, their (Named) Alliance Community Trust is funded 75% of their overall contribution to the Mother Trust after trustees pay, which is in this case $(2.5k \times 100 = (250k - 1\% = 247.5k) - 25\% (61,875) = 185,625 - 1\% \text{ (1.8k (Named) Alliance Community Trusts 3 trustee total pay or 900 each per quarter)},$ for 183,760 in the (Named) Alliance Community Trust the following quarter giving the members that amount to propose, and enact spending for.

The formation of this formula is inspired by source direction to the vision holder for the Alliance, which is based on 25-75, or self to trinity. The Alliance will become familiar with the formula and calculate for themselves, becoming an extra source of vigilance on the financial integrity of the Alliance. The Founders and the Mother Trustees, and the (Named) Alliance Community Trust trustees may not receive above 1 million per anum, no matter how large the Alliance becomes. If the amount need to administer the Alliance is less than the amount (25%) set aside, or if the Alliance founders wish to offer a new service for the good of all within the 25% allotment they may do so, and they may choose to propose to the whole Alliance a use for money in excess of what is needed to administer the alliance, in any case the books of the Alliance are open to every member.

The idea is to enhance true prosperity coupled with ethical conduct, thus the term Prosperism.

The CEO can send messages to their own community by developing their own mailing lists and can submit items to the Alliance Only newsletter which will be sent to emails of members separately from EdensBay Market newsletters. CEOs create communication outside of the Alliance, depending on their desire for private communication. The Alliance may develop inter-alliance style social media and communication for privacy.

This leads directly to our description of PEG_m; Proposal Enactment Governance.

PEG_m: Proposal Enactment Governance

At the heart of the Alliance is the method to easily make group decisions, entitled PEG. Implied in its name, it operates on proposals made by members. The young Alliance will begin use of PEG for the disbursement of funds from the Mother Trust and from Communities, and the outcomes will be tallied and delivered every quarter. As the Alliance trains itself to use PEG, its use is adapted to more needs. At the onset it is employed to provide a rewarding outcome within a short time cycle. The 25% retained by the founders to administer Alliance services is used in part to deliver PEG, and to deliver informational videos and materials that enable the Alliance to grow with the tools we offer.

While PEG_m is an online experience, it can be implemented (and has been), for in person use. For the purposes of this handbook, let us look at what PEG will look like for the Alliance Member. The New member will be introduced to the PEG location, where the member will see the option of looking at the four cornerstones and the open membership tabs, as well as the Communities that have arisen, which are offered their own PEG when they have 2500 members, and if the member has chosen to be in a community, they will be able to put input into proposal fields for any one of 5 tabs: the four foundational cornerstones, and the Alliance Community they belong to, or if no community has been chosen to belong to, for the Open Alliance sector.


The PEG fields for each is as follows: the Input Field, where the short statement proposal (250 words) is made, with links to documents or external sources, such as websites or social media pages as needed to describe the proposal in full. The proposal once entered cannot be edited, but it can be deleted by the proposer only, or by the Trustees or the Founders if it is incompatible with the good of all (in such a case Natural Justice may be employed by anyone regarding that event). This field if viewed on a laptop would be in the upper right hand quarter of the page.

Once the proposal has been entered (and again members will have access to the four foundational cornerstones and either the Open Alliance or a community or a number of communities and the open Alliance as selected by the member themselves). It drops to the 'most recent' position, and the proposing member may vote for their own proposal, get a link to encourage other members to vote for it, or even encourage new members to join to vote for it

(new members, of course, must meet the terms of membership and agree to them). It gets a number according to the chronological entry of its making, in terms of the year and quarter- thus if the proposal is made during the second quarter and is the 758th proposal of 2026 it will be numbered 2Q-758-2026. If that proposal is identically reentered the following quarter, it will retain its number, identifying its date of origin, since perhaps the proposer wishes to do more outreach to create more support. The members will have support creating proposals and fashioning them for success.

The proposal will have a number (2Q-758-2026) and show the number of votes for it (1) at the onset, more voted appearing as more members support it. There is not a need to show “down” votes, since we only need to show which proposals appeal the most. It doesn’t also follow that everyone needs to vote proposals up in every category they belong to, this participation is also entirely voluntary. The Founders will be working with members to make the process interesting and rewarding and simple, so that engagement is maximized as an activity of interest to members. The amount available in every Foundational Cornerstone, Open Alliance portion of the Mother Trust or in (named Alliance Community trusts) **Empowered by the Alliance** is on display, having been established the quarter prior. A running number (shall at some point be added) showing the next quarters’ fund availability according to the volume of subscriptions entering during the present quarter -as an incentive.

This is basic description of the PEG layout for Proposals, the lightest green where the proposal is entered, and the screen below when it is published, then on the left the proposals rising with up votes. The search and tab functions are shown.



If the PEG is used for electing new leadership to trustee status, then the tab for election will be selected and fields will describe the role to fill, and the entrant to fill it, along with the bio/media. The existing Trustees may/shall also put their desire to remain in position in as a proposal with links if desired and the outcomes decided by upvotes. In such a case, in the election tab use of PEG, each election will provide the member with 5, or 3 upvotes depending on the election/reelection of trustees to the Mother Trust or to a (Named) Alliance Community Trust.

Members can propose to make an election of any role needed, and in the proposal, field describe the role needed and propose a funding amount. If this proposal is favored, it moves to the election tab within PEG, which will accommodate the election by naming the role and allowing entrants to be made with links to their positions, videos of them etc, and if the entrants are numerous, allow for biweekly outcomes of top selected entrants until the field is narrowed, and in the last phase, members may pose questions which each entrant answers and publicly recorded collective sessions wherein the entrants have a round table together, discussing the role and another where the entrants answer members questions live. These recordings will be made available to the members for a week prior to final selection of the entrant deemed best positioned to fulfill the role. The proposed role shall have a sunset and may be renewed by proposal. The winning entrant shall be able to propose to the members for additional funds, and they each or all shall be sharing the progress of fulfilling their role to the members.

Any election process shall take place within the space of a quarter, with outcomes completed in the final month and the election processed on blockchain, as well as other PEG outcomes.

Members may propose any alternative.

An emergency PEG can be created and sent by text to all members, with a time related need. For example, in the case of a disaster, a proposal alert may be sent to the phones of those members willing to get such an alert. Additionally, it could very well occur that a community of emergency responders becomes active within the Alliance and while their (Named) Alliance Community Trust (if it has enough members) is funded, they may propose additional funds from the Members to meet any situation.

Members may propose in the following places: for use of the funds in each of the foundational cornerstones, and either in the open fund, and in the communities they belong to. They shall all have the use of election PEG for trustees of the MotherTrust on a cycle of 5 years, staggered, so that one trustee can be replaced a year, with the initial trustees selected by the founders, and subject to reelection 1 year after the Alliance grows beyond 250k members, beginning with the trustee of the Open Funds, followed by the Law, Education, Land, and Wellbeing trustees. Any trustee is subject to the Natural Justice mediation outcome and should any accusation to any trustee move beyond the 2nd circle of mediators, that process is public and the third mediative circle may choose to remove the trustee, as may the 4th. The Natural Justice process is fully explained later in this handbook.

The Volume of the Mother Trust - 2

This means that, using our example of 7.5 million arising from 100k members selecting 35 a month (for receipt of 35 Allied Coins), that -after paying the 5 trustees each 5k per month (15k per quarter 75k in total for all 5 as 1% of new revenue in the Mother Trust) the FC (Foundational Cornerstones), will display 464.k (rounded) available to spend (in dollars, pounds or potentially Euros etc) that quarter, and the rest of the funds (5.7 million +) will be in the Open Alliance section if there are no Communities with 2500 members established.

With 100k members using 35 a month in Allied Coin, therefore, the membership will have significant funds to disperse into economic realm for the members. This fund will be replenished every quarter by existing subscriptions and new involvement in the membership, and voluntary movement into greater amount of Allied Coin.

International Alliance Involvement

Where the Alliance arises in new countries with different currencies their pool will be expressed in their currency, and their alliance may be structured somewhat differently to provide the same shielding, where their foundational laws do not otherwise allow what American citizen can do. The same effect can occur if the Alliance is structured as a corporation in another country, and all the members are co-owners by virtue of their subscription, and the allied coin exchanges, therefore are inter-office exchanges and disbursements are costs of doing business. All this will be examined and vetted for maximum economic empowerment of Alliance membership across the countries that participate, again beginning as a focus group, arising into a convergence of intent to include another country.

A President of the Alliance

A president of the Alliance shall be placed and latter PEG-elected when the membership rises above 1 million. This president is a spokesperson for the Alliance, without authority over the Alliance. She or He can attend meetings and deliver intentions to and from the Alliance, however, the Alliance President must only attend meetings or confer with outside entities that are openly shared and recorded for access by all members, removing secrecy from every corner.

Should members of the Alliance wish to replace the president at any time or add to the role, they may propose a replacement and put a new PEG process to do so, however no president ought to claim that role for longer than 3 years. Payment for this Alliance representative shall be initiated when the Alliance selects an president through PEG and names a level of reimbursement, prior to that election, the President is one of the founding partners, who is paid through alternative avenues by the EdensBay-Alliance venture.

Inter-Alliance Collaboration

The CEO's of communities of the Alliance may find it useful to host meetings with their communities or with several or many, virtually and/or inperson, to encourage even greater repair

of mutual wellbeing and peaceful coexistence and improved practices for the Alliance. The Funds that sit in the Mother Trust and the individual (Named) Alliance Community Trust may be proposed to be used for this purpose, and as described, the CEOs, the Trustees, and the Founders may initiate proposals that are specially visible by virtue of color or identification in newsletters.

The Trustees of the Mother Trust and the (named) Alliance Community Trusts, shall be mutually available and meet weekly or monthly remotely to assess and address issues that may arrive. The Community CEO's shall be invited to attend such meetings. The entire body of trustees (mother trustees and community trustees) across a national alliance shall meet once a month, for best practices, and these meetings shall be recorded and made available to All Alliance members. There will arise new trusts as land is purchased, and these trustees will be placed with the same terms of honoring the Alliance allegiance, and host weekly regular meetings for their subcategory of Alliance Land trusts and attend the monthly meeting of all trustees.

Trustees from across the globe shall meet quarterly, and confer and compare for best practices. The trustees shall allow mentorship of next generation trustees so that the roles are familiarized and well understood prior to election. This means that interested trustees may attend meetings as observing learners.

Trustees spend time in the field

All Trustees shall expect to spend significant time in the field watching the projects, and providing proper oversight of the expenditure of the funds according to the outcome of the Alliance's PEG Process, helping the recipient to be successful or initiating a Natural Justice process if there is failure to honor.

Trustees shall be responsible to make certain the progress on the funded proposals are depicted for the benefit of the Alliance. These funded projects shall be made visible on a section of the Alliance.land website, searchable by a variety of terms. Some of the projects should be featured on the EdensBay site to promote the Alliance.

It should be obvious that proposals that are not entirely honorable, wholesome and useful, any proposals that seek to create any undermining of Natural Law are removed from consideration by oversight from the Trustees, the Members and the Founders.

If the mediators of Natural Justice decide the disbursement should not occur as proposed, the disbursal shall be halted and restored to the trust it arrives from. If money has been spent prior to this, and spent without honor, the mediators shall decide whether the Alliance member has the capacity to make the Alliance whole or should be removed.

Cryptocurrencies

Crypto currencies may be used according to the wisdom of the founders, members and trustees. The Allied coin is, incidentally, a stable coin that remains in circulation within the Alliance only, but across national lines. Therefore, it follows that the EdensBay Marketspaces will accept local public currencies, the pound, the dollar and crypto currencies, Bitcoin, Ethereum etc, TBD, and enable exchange by Alliance members only of Allied Coin.

Alliance and EdensBay

EdensBay is a separate entity than the Alliance because by making it autonomous we create a minimal contact environment, removing the connectivity to adhesion contracts of corporate government entities. The Alliance is for flesh and blood living beings, not the corporate entities that have been created on our behalf for the purpose of binding people to contracts that may not be known and must be opted out of. As the Great Awakening expands, knowledge of the Strawman and its use to surrender the people to corporate elites is becoming more common. A small booklet available on Amazon for under 6 dollars (later on EdensBay) called Meet your Strawman, by David E Robinson is an excellent start to see the scheme of indenture and enslavement that has been employed against the Natural Rights of the people. This Alliance handbook is not the place to expand on the history, however, within the Alliance those who have uncovered this knowledge will be bringing it to those who need it, offering services and education protecting our new realm from the corrupt practices of the old.

By making the Alliance a wholly separate entity that integrates with EdensBay the Alliance's activities can be protected and permitted by constitutional law as our right to privately contract, a right that shall not be impaired, unless the contractual substance is demonstrably 'evil'. Of course, we create the private membership realm because of malefic forces, not to institute new

The Alliance begins with a period of growth and testing of PEG, and the Allied coin, not unlike the tender steps one takes before one feels secure on a stone across a stream, with time and use the Alliance self corrects issues and the realm becomes stronger, and trades are matters of confidence with the Allied coin, the PEG method is second nature. As that happens the Alliance can take on greater forms of empowerment, it can adapt its use of PEG for more collective empowerment, and decisions. One day it will be ready to increase (or decrease) the Allied coin in circulation, according to the needs of the members and the external economic elements in play. The Allied coin could remain an untaxable medium of exchange that augments the Alliance's capacity to trade while creating a resource pool for new and expanding businesses, or any other proposals, such as land purchase, health resources educative, and legal protection, that must be spent into the public realms of commerce, or it could become the preferred medium for alliance members which of course depends solely on the breadth of the Alliance.

It is worth noting that alternative currencies in small communities are like fish in a small aquarium, they stop at the edge of the glass, and thus the fish within cannot use it beyond the glass. The Alliance PMA is structured to allow for expansion which allows for local focus and growth, while interconnecting the whole movement. It is the sea compared to the aquarium. The metaphor fails at this point.

Co-Ownership of EdensBay

EdensBay is co-owned by aligned people, who invest and receive shares for their investment that will generate income if the risk pays off, once the Marketplace moves into prosperity. Shares are 100 apiece, and 11% of the company is available to purchase to Alliance members; the investing member agrees to the PMA terms and the Natural Justice method. EdensBay, run properly will be enormously beneficial and prosperous, for numbers of people. Imagining a reversed Amazon, for everything that is honorable to purchase, goods, services, education and events leaning into a

regenerated Natural world, free of toxic practices, where young families and wise people can trust that their dollars are not used to make a billionaire swell, while extracting maximum from employees, and producers for minimum, and from business itself, EdensBay creates an environment of substance, of sharing and of abundance.

There are two classes of shares, one for Alliance vendor-members who purchase 10 or more shares (1K), this class allows for the EdensBay Vendor owners to propose better practices to Founding Owner team and thereby be more involved in the running of the company, its evolution and responsiveness to the needs of the Alliance. These vending owners at start up stage are needed raise capital for the Beta Site, and proof of concept for EdensBay. These vending owners are non-voting.

The second class is for non-voting and non-proposing shareholders, at 100 per share. These investing members will be helping to bring the venture into fruition for the Grand opening of EdensBay. Their investment will be returned as the company prospers.

Sales of Shares

The member-investors and vendor-member investors can sell their shares to other members, they may not sell them to any individual or company that is not in alignment with the Alliance PMA. Investing members have contract wherein they do understand that at the onset, their investment is at risk, however, this venture has life dedicated leadership.

Although there are more private forms of business that EdensBay could be, a UNA, for example, an unincorporated nontaxable entity, the counterintuitive (to some) reason to establish edensbay within the corporate framework for business as established by a governmental entities who themselves are decrying the Constitution, is to allow for least suspicion, and provide a comfort level for the generally concerned, but not informed, who are often suffering from all forms of fear. EdensBay is a hybrid for the fearless metamorphosis to **Prosperism**, wherein private trade using allied coin and cash occurs side by side with public commerce in public currencies (regulated by extractive exploitive entities).

Our trade activities shall be ordained and obviated as substantially reparative for all the issues corporate governance entities claim must occur, only EdensBay and the Alliance has outcomes that actually repair health and wellbeing, rather than simply undermine the same with coercive and fearmongering non-solutions. Where “smart cities are the solution to climate change”, EdensBay and the Alliance provides a better solution. A provable and scientifically sound solution, one that retains and opens the full rights of members to act on behalf of the repair that is needed.

Many may not be aware of the corporate malfeasance at the regulatory level, and the nonconstitutional removal of liability from companies that are actively poisoning our lands, making them more flammable and creating dead soil and erosion of human and natural health. While there are people pushing back within the existing system, meanwhile the Alliance and EdensBay provides a way to move forward with repair, outside of corrupted entities. It is important that the Alliance understands the structure of self governance and monetary empowerment, so that leadership is shared across lands and nations.

Standing as a separate entity from EdensBay gives the Alliance a stronger foundation, for use of it will bring familiarity with the form, and from that arises the capacity to respond to failures as a large body of people. Should EdensBay become something that the Alliance is not served by, the members will have the knowledge and capacity to make a different path.

EdensBay as an LLC could be subject to change, however, should the form of EdensBay change (eg become a member owned trust company, or a UNA), responsibility to the investing members will be honored. A change of that nature will be with collective EdensBay shareholder understanding and buy-in.

The principal owners of EdensBay are people who have invested their life work to fairness, responsible action and excellent outcome. These are people who are not interested in becoming billionaires on the back of others, these are people who reap their rewards from spiritual honorability. While we look forward to the proper prosperity our efforts will bring us, that empowerment means each of us shall be financially capable to bring more substantive benefit to others, in the unique manner we each have a passion for. None of the owners wants or seeks uber

wealth, instead our goal is for more people to experience wellbeing of prosperity with right action towards Nature. We seek to create a better legacy together.

Stewardship

The Alliance's MotherTrust, along with the substance of concern within align members for the repair of our Natural Environment, and enabling next generations to position themselves with land security and skill sets for doing so, brings an approach to land that involves placing lands in trust for those who have the intention to bring honorable practices to bear. With stewardship as a service greatly needed, the Alliance is structured to provide capital and expertise to put lands into trust with language for beneficiaries to have life-long occupancy contracts with survivor rights, leases only penetrable for reasons of environmental harm. Trusts can be structured to allow for movement from one land holding to another by beneficiaries. Because the land will be in trust, the occupants are not owners, the Alliance Mother Trust owns the land, or communities within the Alliance large enough to hold their own Trust owns the land. In general, use of trusts are beneficial for the members of the Alliance, and use of them will be more understandable to the members of the Alliance as membership elects trustees to the Mother Trust, or the communities' sub-trusts, or trusts for stewardship of land.

The Alliance PMA Agreement

ALLIANCE MEMBER

THE ALLIANCE IS A PRIVATE MEMBERSHIP REALM

Terms of the Alliance Membership Agreement

1.

*The Alliance is a Private Membership that
contracts privately together.*

Members must be of the private sector.

If you work for Government as a member of local government, the legislature of any State or Federal Government, the Judiciary, Executive or as a bureaucrat for any of the above, except Veterans, Postal Workers and Teachers, you cannot join the Alliance as a member or a vendor.

By becoming a Member you affirm you are a member of the private sector or are a teacher, a veteran, or a postal worker as described above.

2.

The Alliance Exists for Honor

*Alliance Members, Vendors and EdensBay Co-Owners
pledge to maintain the highest standard of honor and ethical behavior.*

A higher standard of behavior is expected of all members.

- *Members are accountable.*
- *Members' word is their bond,*
- *Members' words are truthful,*
- *Members obey the Golden rule.*
- *Our trustworthiness is the source of our empowerment as
an Alliance.*
- *Members agree to hold each other*
- *accountable with Natural Justice.*

3.

Natural Justice

As a Member, you agree that any disagreement, or accusation of wrong shall be resolved within the Alliance membership, on the basis of Natural Law, this process will be fully in place at the onset of Grand opening of EdensBay and membership subscriptions. All Accusations that arise between members shall be resolved in this manner and members knowingly and willingly accept the Natural Law process, and forfeit statutory remedy. Members pledge to be held to the outcome of the Alliance's Natural Law. All acts of a violent criminal nature shall be directed to external governmental processes.

The process of Alliance Natural Justice will be shared with all members prior to subscription payments and Grand opening in the Alliance Handbook, and is available now upon request.

4.

Freedom Works

Members understand and support each other's privacy as a matter of right to live with a reputation of full innocence in an environment of liberty, creativity and honor. The Alliance will generate increased privacy for members, offering new levels of privacy at every opportunity. How one spends one's money, where one travels, who one speaks with, what one chooses for medical care are all personal and private matters insofar as they are conducted without evidence of harm to others. The freedoms of our God instructed rights shall be upheld and fully implemented within the Alliance. Evidence of wrong doing or harm shall be followed by accusations to be vetted in the Natural Justice Process. The Alliance shall not be subject to unlawful non-constitutional demands devised without participation of members. Members agree to protect the private affairs of Alliance members, this means to refrain from sharing information to outside entities -rather refer those entities to the individual for their consent. It means to allow the private contractual trading realm to operate in the sunshine of privacy, not shaded by a net of surveillance gathered by unknown, unvetted entities for control.

5.

Consequences:

If a member surrenders another member's private information without consent, an accusation may be initiated in the Natural Justice process, and the mediators shall provide the resolution as described in the process.

If an individual joins under false pretexts; who is not in fact a member of the private sector but does so for the purpose of disrupting, undermining or spying on Alliance members, or for any nefarious purpose, such as attempts to use the Alliance to launder money, or to traffic children or drugs, that person herein, by joining fraudulently, herein agrees to pay up to 75% of their total wealth to the Alliance without recourse, should the Natural Justice process prove an accusation of this nature against them. Joining the Alliance is a bridge into honor, and the Alliance will not tolerate individuals acting without it. There are plenty of Alliance lawyers to attend to the retrieval of any perpetrators' wealth which will be placed in the Alliance's collectively held Mother Trust for use by all.

6.

Prosperism

Members understand that we create this Alliance to undertake a reformation of economic principles, wherein our true collateral is our collective protection of happiness, health, wellbeing with capacity for mutual respect for one another's freedom, and of Living Nature. This means there is no limit to wealth obtained through honor, and integrity by offering services, talent or products that do not indenture, extract or harm others. Our standards of inclusion are built on best stewardship of land, health, family and creative purpose.

Members agree to act on economic principles of 'prosperism', when using the Allied Coin, and Allied Cash, rules of which are designed to deny money as personal power to indenture, enslave, harm or extract aside, and entering into mutual empowerment via collective management of money flow. Members collaborate, propose and contribute to, and oversee the growth of the Alliance, its internal coin and cash, and its commerce site, EdensBay.

Ultimately the Alliance agrees to be mutually empowered to efficiently co-manage the amount of Allied coin and cash in circulation needed to fulfill Alliance needs.

7.

Allied Coin

Members voluntarily utilize their private Allied Coin currency, augmented with cash designed from gold leaf and silver coin. Vendors voluntarily agree to accept a portion of their sales in for Allied coin, which is exchanged with other Alliance member purchasers as a private contract. EdensBay will provide accounting services to that end. Vendor-members who do accept allied coin will be able to accept cash disbursement from the Alliance MotherTrust, or an Alliance Community minor-trust on behalf of their business. These vendors will be obliged to accept Allied coin in an equal amount of their disbursement and display their honorable use of the funds, before any more disbursements can be made to an individual vendor. Allied Coins shall not be redeemed for public currency by the Alliance PMA or EdensBay LLC, but they may be sold within the Alliance to according to terms made by parties to the sale, as long as they are not for nefarious purposes.

8.

Respect of Living Nature

Members understand the overarching purpose of organizing ourselves in an Alliance PMA is to collectively detoxify Nature, repair living soil, air and water with regenerative and humane farming, expand sustainable nontoxic building design and implementation, to produce more clean products absent a variety of poisons, to upgrade our food supply for maxim nourishment, and to rebuild our health modalities without conflicts of profit motives, but within Prosperism's guidelines.

The Alliance as a whole works towards lawful cessation of extractive destruction of Nature for profiteering and places lands into trusts for generations to come, who may stand and live on these lands as per their measure of stewardship, in perpetuity. Therefore, celebrating the wisdom gleaned from within the Alliance for best practices, new and old, and have the ready funds to invest in them is understood by all members.

9.

Respect of Religious Peace

Members understand that each living soul is a conduit of Source God energy, and is here alive by virtue of that personal relationship. In pursuit of that relationship all members allow this shows up differently for each person or differently for different sets of people. What one does with one's body, so long as it does not affect or harm another, is between that individual and their Source God guidance, and members agree to tolerate without enforcing different religions and beliefs. However, no person may be a member of the Alliance while participating in any belief structure, religion or organization that believes itself more worthy or ordained than any another member or any other religion or belief. No member shall be retained who serves any belief that their religion is specifically "chosen" by Source God to be permitted dominance or violence against any other religion or belief sets.

Peace for Alliance members shall be established, served and rigorously maintained.

10.

All Learning

Alliance Members understand that to create a better world we will be learning how to reshape ourselves, and that the Proposal Enactment Governance model used initially to decide where distribute and disperse funds through the Mother Trust to beneficiary projects will also be used in other contexts, to improve our Alliance, to strengthen our bond to uplift humanity, to regain the authority for a clean and peaceful world. By joining the Alliance you understand you are personally invited to contribute your wisdom and to vet the wisdom of members. You are entitled and encouraged to call out wrongdoing where you see it amongst members through the Natural Justice, and to join efforts of members' communities who are dedicated to denying all external corruption, to understand the rights we have and to employ them successfully. In time, the Alliance will be a global community that will be populated with strength and commitment to prosperism and peace. The Alliance will at that point design through proposal enactment our Great Earth Constitution.



This Agreement is binding to the members of the Alliance, however until such time as the Alliance has substantial membership to employ Natural Justice, the members will rely on existing arbitration services. Natural Justice works as follows:

Natural Law



Introduction

It can be used to provide a just environment for complete remedy with an absence of legal complexity wherein corruption breeds. Once Alliance members become familiar and comfortable with it, it can entirely replace the legal system that currently has failed the full measure of peace and its repair. It should be noted that the Alliance hosts experts who can stand in the existing legal systems with success, and these individuals are working in a much more complex environment. The Natural Justice approach is not complex, yet it allows for complex and tailored outcomes.

**NATURAL
JUSTICE**

What is Natural Justice?

Natural Justice is the form of Justice that most closely follows the Golden Rule: Do Unto Others As You Would Have Them Do Unto You, and to Do No Thing to Another That You would Not wish done to you. Harm no one who harms you not or your loved ones not. Walk in innocence and repair peace with strength, power and persistence.

-4-

Rights

Our rights to Life, Happiness, Property, Bodily Autonomy, Liberty, Peace, Travel, Speech, Religion, Freedom from Search and Seizure, right to Justice, the right to reform our mutual governance for a more perfect union, are Naturally Endowed by virtue of our personal creation by Source/God. For the Alliance, our right to privately contract for all interactions that are not 'evil', is consequentially important. The Alliance recognizes these rights and more for members of all lands.

-5-

Innocence

In Natural Law, our behavior is compared to the Golden Rule, and if someone in the Alliance finds our behavior wanting, they make an accusation. Of course, a member that overuses this process may themselves be the object of an accusation. Absent any accusation, the member shall walk in freedom of fear of guilt. An accusation may be made in anticipation of harm.

The steps to Natural Justice

If a person has an accusation to make on another, they make it to a first circle mediator. The first circle is just one person, and it is the first of four circles to repair peace.

These persons are for the starting of the Alliance, volunteers identified on Alliance land by their interest. Later, they may be remunerated by PEG initiatives.

The two (or more parties) are labelled; 'Parties to an Accusation' and not: defendant, plaintiff, complainant, claimant, perpetrator or victim. They shall be called accuser or accused. The term witness shall apply accordingly, and mediators shall be called according to their circle: 1st circle mediator, 2nd circle mediator, 3rd circle mediator and 4th circle mediator. The 2nd, 3rd, and 4th circles shall select a Facilitator and a record manager. The 1st circle mediator shall be solely one person in charge of recording the parties and facilitating the remedy.

-7-

Process

The First circle mediator looks for a remedy that will restore peace, and seeks agreement from both parties to abide by it. It's important to bring even small issues to peace early. If the remedy does not sustain peace, the matter moves to the 2nd circle of mediation. Both the 1st and 2nd circles are held in private, with all evidence, calls, and recordings passed from the 1st to the 2nd circle. The evidence, and recordings are stored sealed, unless the matter fails to be resolved.

2nd Circle Process

The 2nd circle of mediation has 6 mediators, like a petite jury, only no judge is needed, nor lawyers. The mediator from the 1st circle, passes the recordings/ evidence from the failed 1st circle mediation effort to the second, unless a dedicated service has been established. One Facilitator is chosen. The parties to the accusation come before the 6 mediators who ask questions, seek witnesses or evidence and finally offer a 2nd remedy, delivered through the 2nd circle facilitator.

3rd Circle Process

The 3rd circle of mediation has 12 mediators, like a jury, without a judge or lawyers. A 4th circle Facilitator is chosen. Recordings/ evidence from the failed 1st and 2nd circle are first presented to the 3rd circle for review, next the 3rd circle shall meet with the parties for further inquiry. They may by choice, meet with them separately or together. They may seek witnesses or further evidence. The general Alliance may witness the process remotely.

Process becomes Public

Up to this point the Natural Justice process has been private, not held for the public to see. If the second circle's remedy fails however, the matter and its evidence becomes publicly accessible within the Alliance. This is a strong motivator for parties to an accusation to apply themselves to the 2nd circle's remedy.

Also, the members of the Alliance are held to be truthful in all their words, and are held to their statements as under oath at all times. Truthfulness is our accepted standard.

4th Circle Process

The 4th circle of mediators is 24 people strong, and, like the mediation circles before them, a facilitator is selected and recordings and evidence is reviewed. As before, members of this circle may ask questions, may seek witnesses, and evidence, and and may meet with parties absent the other, or together. All meetings are recorded and shared with the Alliance in the 3rd and 4th meditation circles.

3rd Circle Process

The 3rd circle delivers a remedy, and the remedy may be for either both, or all of the parties to an accusation. Harm does not have to have occurred for an accusation of dangerous outcome to be made. If the matter remains in conflict after the remedy offered by virtue of 12 people attending to the discord, the matter of the accusation moves to the final and 4th circle of mediators.

4th Circle Process

Should an issue reach the 4th circle of 24 mediators, this indicates a difficult conflict since it requires the time and attention of so many members. Members are expected to be open to remedies created by the mediators, and respectful of the personalized attention to their situation. Since the process is interactive, the parties can propose remedies themselves.

4th Circle Process

The remedy provided by the 4th circle of 24 mediators constructing peace from discord, is implemented, there are no further circles to create any better one. Thier remedy is final . Prior to the 4th circle any of the parties can disown the remedy, which moves the process to the next circle.

Mother Trust Trustees

As the Natural Justice Process is utilized, money may need to be dedicated to the process and the storage of the recordings and evidence. The Mother Trust Trustees shall be responsible for creating a repository for these, and shall make proposals to the Alliance for compensation of mediators when appropriate and any other costs that they may assess needs to be covered.

Mediators

Mediators within the Alliance may identify themselves as useful for Natural Justice process, the circles will be populated by those who are interested in creating a peaceful remedy. In time, Natural Justice mediators will be rated 1-5 for their work, with testimonials and be able to leverage their experience for facilitator roles, and become known in the Alliance for their capacity to restore order. Mediators will have a wide creative latitude of remedy, which is developed from personal interaction with the parties to the accusation.

Jurisdiction

It is understood by every member that the statutory realm of corporate law is not in play in the Alliance or its use of Natural Justice, and that our rights come directly from Source God, and our behavior must honor each other in peace. The Alliance is recognized as a collective of Living Souls, each responsible for abiding by the Golden Rule, the 10 commandments, and the rights as described in the bill of rights of the united States Constitution. Within the Alliance, no person is considered a corporation, or any legal fiction.

More

Larger Alliance Communities have the option of initiating their own internal Natural Justice circles. Where the Alliance exists on separate continents, the process takes place where the parties live. Children can be given practice to use the Natural Justice method.

Jurisdiction

It is understood by every member that the statutory realm of corporate law is not in play in the Alliance or its use of Natural Justice, and that our rights come directly from Source God, and our behavior must honor each other in peace. The Alliance is recognized as a collective of Living Souls, each responsible for abiding by the Golden Rule, the 10 commandments, and the rights as described in the bill of rights of the united States Constitution. Within the Alliance, no person is considered a corporation, or any legal fiction.

Jurisdiction

However, Alliance membership brings with it substantial benefits, and if expelled, the individual may not restore their membership. Should the Alliance grow to use the Natural Justice for matters of criminal violence, it will also need to propose the costs of remedy, if those included isolating an individual who behaves harmfully.

Jurisdiction

Should the Alliance reach a magnitude that it is capable of delivering Natural Justice for all matters, civil or criminal, it might well follow the example of Jamaica, and send the rightfully accused to be sequestered away from the rest of the Alliance on a perimeter-secured area of land, and provided with hand tools, seed, and materials to create food and collect water for themselves, house themselves and remain for a duration described by the mediators. It is highly recommended to employ variations of this remedy for any rightfully accused violent member.

Attorney-free

Within the Alliance there shall be no 'Bar', or certified attorneys. Simplicity of the process, while allowing and creating endlessly tailored outcomes specific to the participants to an accusation, is absolutely our surety against corruption. Mediators will be selected to be of the highest caliber. Natural Justice is central to the Alliance's capacity to cleanse itself of dishonor of all kinds.

Natural Justice beyond the Alliance

Should the Alliance tend to matters of harm from beyond the Alliance the Natural Justice method shall ensue. If any matter is of such serious import, the process will start with the 3rd mediative circle at the judgement of the 1st circle mediator. A Natural Justice 3rd or 4th circle outcome for any matter involving external agencies or entities shall be published and viewable by the Alliance and the Public.

Remedies

Where accusations arise from behavior of addicted or emotionally wounded members of the Alliance, the onsite secured farming experience has generally been shown to be the most remedial, since accruing the skills to survive generates internal growth and capability. These models are vastly more effective than existing mental health systems. This shall become self evident by the outcome.

Conclusion

Natural Law is for people living as equals. Our oath is to one another before Source God, not to a bar association, a corporation, a government or a licensing board. Natural Law gives Alliance membership the full capacity to remedy conflict and inter-alliance crises in a straightforward process understandable by all, allowing for privacy and public scrutiny. When Natural Justice is applied to matters arising beyond the Alliance it shall reveal to all involved its improved methodology if peace is the goal. Wherever Peace is not the goal, these behaviors shall be halted.
